ACE MEMBERSHIP - \$3,962.26+tax
One (1) tee time for four (4) players per day,
includes golf carts and the practice range.

EAGLE MEMBERSHIP - \$2,641.51+tax
One (1) tee time for four (4) players per day,
includes the practice range.

BIRDIE MEMBERSHIP - \$2,264.15+tax
One (1) tee time for two (2) players per day,
includes golf cart and the practice range.

PAR MEMBERSHIP - \$1,509.43+tax
One (1) tee time for two (2) players per day,
includes the practice range.

Coeur d'Alene Golf Club Rules for Corporate Golf Memberships:

- The Corporate Golf Membership does not provide ownership or control over the Club in any way. No additional rights, privileges, nor benefits should be inferred or expected except for those expressly stated herein.
- Allowed up to six (6) company representatives.
- One (1) of your company representatives must show their corporate membership card and accompany/play with the group at all times - no exceptions.
- Only the six (6) company representatives are allowed to book tee times.
- Must provide a valid business license.
- Fees must be paid in full with one (1) transaction - no payments.
- Valid for one (1) tee time per day, tee time may not be split into multiple tee times.
- Membership includes a range bucket for each player prior to their round.
- Tee Times are required and are subject to availability.
- All players must check-in with the golf shop 15 minutes prior to your scheduled tee time.
- No outside Alcohol is allowed on the premises - Idaho State Liquor Law.
- The Golf Shop reserves the right to complete your group by adding additional players to complete a four some.
- Five-some's are not permitted.
- Golf Carts must be turned in by the scheduled sunset each night.
- Each player must have their own set of clubs.
- Players must adhere to the course dress code.
- Players must understand our pace of play policy - we reserve the right to make you pick up and move on.
- Any player under the age of 18 must be accompanied by an adult.
